PLEASE READ AND UNDERSTAND THIS WAIVER OF LEGAL RIGHTS:**

UNDERSTANDING OF HAZARDS: I understand and acknowledge that "Parachuting Activities" and flying, that may involve unavoidable dangers including, lacerations, abrasions, fractures, disfigurement, loss of limbs and/or function, loss of sight and death. I knowingly accept all risk related to my Parachuting Activities, no matter the aircraft, time, place or weather.

Likewise, my Parachuting Activities may involve vintage but airworthy aircraft and vehicles with no guarantee of perfect function or errorless pilotage. I understand that I may be injured or suffer a fatality during my Parachuting Activities. **INITIAL HERE _____.**

I understand Agreement and Release is a binding contract and I have waived all claims against the Released Parties resulting from my participation in Parachuting Activities, including any claims caused by negligence of the Released Parties. I confirm I have the option to not participate in the Parachute Activities. **INITIAL HERE _____.**

CONTINUATION OF AGREEMENT: I understand and agree that upon its execution, this Agreement and Release shall be in full force and effect at all times while I participate, in Parachuting Activities, and shall be binding upon my personal representatives, heirs, executors, administrators, successors, and assigns, until specifically terminated in writing by both parties.

AFFIRMATION OF UNDERSTANDING AND CAPACITY:

On behalf of my personal representatives, heirs, executors, administrators, successors, and assigns, agree to RELEASE and HOLD HARMLESS and INDEMNIFY the Released Parties, as defined at 1 and 2 below. Said parties are RELEASED from all claims, actions and suits, whether in law or in equity, demands, damages, attorney fees, costs, and other financial expenditures that may be brought against or incurred by them, or anyone on their behalf, which is connected to my participation in Parachuting Activities or to this Agreement and Release, whether or not caused by the negligence of any of the Released Parties:

1. Aircraft owners, lessees, pilots, copilots, crew members, mechanics, airfield owners, airfield operations, vendors, shareholders and other individuals associated with the operation or supply of any aircraft or vendors utilised in the Parachute Activities; **INITIAL HERE _____.**

2. The Board of Directors, of Round Canopy Parachute Team – Great Britain, its Staff, and all members and their heirs; **INITIAL HERE _____.**

I understand that RCPT does not provide personal injury coverage or general liability insurance for my Parachuting Activities and that I must obtain proper health insurance that covers injuries from Parachuting Activities or related events. **INITIAL HERE _____.**

STATEMENT OF PHYSICAL FITNESS.

I understand Parachuting Activities requires me to be in good physical condition. I certify that I do not suffer from any chronic physical or mental maladies which would limit my Parachuting Activities including heart disease, blood pressure, lung or respiratory disease, fainting, vision or hearing impairment, muscle and bone disease, diabetes, kidney, neurological or depressive disorders. I further certify that I am taking no medication that would impair or decrease my judgment or ability to engage in Parachuting Activities. I agree to refrain from the consumption of alcoholic beverages and recreational drugs within eight (8) hours of the published show-time for all parachuting and piloting activities. I also understand that even the appearance of being intoxicated or un-fit for parachuting and piloting will result in being banned from parachuting and piloting activities that day and will be subject to future restrictions placed by the RCPT Board of Directors.
